Park Ward Neighbourhood Forum has prepared a Neighbourhood Development Plan (PWNP). The Plan sets out a vision for the future of the area and planning policies which will be used to determine planning applications locally. In accordance with Regulation 16 of the Neighbourhood Planning Regulations 2012 (as amended), the PWNP and associated documents will go out to consultation (Thursday 10th February 2022 until Thursday 24th March 2022) for 6 weeks inviting representations on the draft submission plan, basic conditions statement, and consultation statement.
